#### CHASE RANKIN/EXECUTIVE DIRECTOR REPORT:

Mr. Rankin reported that Brent Baggett would be doing a marathon in Tokyo, his last marathon of all the majors.

Mr. Rankin reported that the staff had been updating the website for the Pension System.

Mr. Rankin reported on HB 4051 regarding military credit. The bill would allow active duty military service that does not otherwise qualify for credited service to be purchased by the firefighter at the actuarial cost.

Mr. Rankin reported on the COLA Bills, HB 1290 is a 2% increase and HB 1277 is a 4% increase. Mr. Rankin said this could cost the System \$72 million if approved.

Mr. Rankin reported on SB 453 which would raise the volunteer multiplier from \$7.53 for every year to \$10.00 a year. Mr. Rankin said this could cost the System \$17 million.

Mr. Rankin reported on HB 1824 which is the Death Benefit Bill which would raise from \$5,000 to \$7,500.00. Mr. Rankin said this could cost the System \$28 million.

Mr. Rankin reported on SB 1443 which is the Technical Correction Bill.

Mr. Rankin said HB 2991 has come out of committee. Mr. Rankin said it allows volunteers who have retired to go back to work.

#### DONNIE BENNETT LEFT THE MEETING AT 12:25 P.M.

Mr. Rankin reported on HB 3541, which is the Energy Elimination Act. Mr. Rankin said he had concerns for this bill because it does not allow exemptions.

Mr. Rankin reported HB 4014 is also the Energy Elimination Act, but he had no concerns about it.

Mr. Rankin reported on HB 2254 which is the TSET bill. Mr. Rankin reported he was monitoring to make sure pensions did not get included.

Mr. Rankin reported on HB 1617, which would require pension systems to vote their own proxies.
