CHASE RANKIN/EXECUTIVE DIRECTOR REPORT:

Mr. Rankin reported on HB 4051 regarding military credit. The bill would allow active duty military service that does not otherwise qualify for credited service to be purchased by the firefighter at the actuarial cost.

Mr. Rankin reported on the COLA Bills, HB 1290 is a 2% increase and HB 1277 is a 4% increase.

Mr. Rankin reported on HB 3541, which is the Energy Elimination Act. Mr. Rankin said the bill had moved out of House to the Senate and he was watching it closely.

Mr. Rankin reported on HB 1617, which would require pension systems to vote their own proxies.

Mr. Rankin reported on HB 2991 is the IRS update bill.

Mr. Rankin said SB1524 allows volunteers to continue to serve the community as a firefighter in retirement once they have received the maximum allowable benefit.

Mr. Rankin reported on HB 1824, which would raise the Death Benefit from \$5,000 to \$7,500.
